



### ABOUT THE I-495 & I-270 P3 PROGRAM

The I-495 & I-270 P3 Program is the largest initiative under Governor Larry Hogan's Traffic Relief Plan (TRP). The Program seeks to deliver traffic relief as quickly and efficiently as possible along nearly 70 miles of I-495 and I-270 in Maryland.

The cost of congestion in the National Capital Region grew to nearly \$1.3 billion in 2016. The cost will only continue to grow as the population in the region is expected to increase by 1.2 million by 2040.

We need innovative solutions to relieve congestion now. MDOT invites private industry to help us address the transportation challenges on Maryland's most congested roads.

Currently, MDOT is evaluating P3s to finance needed improvements. The P3 could create innovative opportunities to fund improvements with the least financial burden on Marylanders. Our approach is to implement improvements that will provide congestion relief to the region, without additional state tax dollars—that is, at no net-cost to the state.
